excluding shares in an Individual Retirement Account or in any other account that would lose special tax treatment under state or federal law, and (d) collateral securing other loans you have with the Credit Union excluding dwellings.

#### Other Fees & Disclosures:

## Late Payment Fee:

\$27.00 or the amount of the required minimum payment, whichever is less, if you are 27 or more days late in making a payment.

### Balance Transfer Fee (Finance Charge):

5.00% of each balance transfer. However, this fee will be waived after the promotional period stated on the previous page.

#### Cash Advance Fee (Finance Charge):

\$5.00 or 2.00% of the amount of each cash advance, whichever is greater.

## Returned Payment Fee:

\$27.00 or the amount of the required minimum payment, whichever is less.

### Card Replacement Fee:

\$15.00.

## **Document Copy Fee:**

\$2.00 per document.

## Rush Fee:

\$35.00.

## Statement Copy Fee:

\$2.00 per document.
