Promotional Period for Introductory APR:

Any existing balances on ValleyStar Credit Union loan or credit card accounts are not eligible for the Introductory APR for balance transfers.

For California Borrowers, the Horizon Visa and Horizon Visa Rewards are secured credit cards. Credit extended under this credit card account is secured by various personal property and money including, but not limited to: (a) any goods you purchase with this account, (b) any shares you specifically pledge as collateral for this account on a separate Pledge of Shares, (c) all shares you have in any individual or joint account with the Credit Union excluding shares in an Individual Retirement Account or in any other account that would lose special tax treatment under state or federal law, and (d) collateral securing other loans you have with the Credit Union excluding dwellings.

Other Fees & Disclosures:

<u>Late Payment Fee:</u> \$25.00 or the amount of the required minimum payment, whichever is less, if you are five or more days late in making a payment.

<u>Balance Transfer Fee (Finance Charge):</u> 5.00% of each balance transfer. However, this fee will be waived after the promotional period stated on the previous page.

Returned Payment Fee: \$25.00 or the amount of the required minimum payment, whichever is less.

Card Replacement Fee: \$5.00.

Document Copy Fee: \$5.00.

Emergency Card Replacement Fee: \$150.00.

PIN Replacement Fee: \$1.00.

Rush Fee: \$18.00.

Statement Copy Fee: \$3.00.
