Promotional Period for Introductory APR:

The Introductory APR for purchases and balance transfers will apply to transactions posted to your account during the first 90 days following the opening of your account. Any existing balances on ValleyStar Credit Union loan or credit card accounts are not eligible for the Introductory APR for balance transfers.

Loss of Introductory APR:

We may end your Introductory APR for purchases and balance transfers and apply the prevailing non-introductory APR if you are 60 days late in making a payment.

Late Payment Fee:

\$30.00 or the amount of the required minimum payment, whichever is less, if you are 10 or more days late in making a payment.

Balance Transfer Fee (Finance Charge):

5.00% of each balance transfer. However, this fee is waived on any balance transfers posted after the promotional period as stated in the Promotional Period for Introductory APR section.

Returned Payment Fee:

\$30.00 or the amount of the required minimum payment, whichever is less.

Card Replacement Fee:

\$20.00.

Emergency Card Replacement Fee:

\$150.00.

Rush Fee:

\$35.00 delivery available in the U.S. only.
